Municipality of Tinian and Aguiguan

Established by Article VI, Section 3, the Mayor of Tinian and Aguiguan shall administer government programs, public services, and appropriations by law.

The Office of the Mayor has a total of 20 divisions, and each of these divisions are responsible for administering programs and services to the community and the residents of Tinian.

Additionally, the Mayor appoints eight Resident Department Heads that must be confirmed by the Tinian Municipal Council to lead extended executive branch agencies that consist of Department of Commerce, DCCA, DOL, DPS, DFEMS, DOF, DLNR and the DPW.

FINANCES & REVENUE REPORT (FY 2025)

The Municipality of Tinian and Aguiguan operates on a budget appropriated every fiscal year. The funding sustains the Office's personnel, operations, government services and programs. Local revenue is also generated through government agencies, municipal public services, and a regulated gaming industry.

The Tinian Municipal Treasury is responsible for a portion of the Municipality's financial obligations identified to sustain its municipal programs, scholarships, projects, and professional staff. The breakdown of the finances and revenue below will outline the local funds received through local law appropriations passed by the Tinian and Aguiguan Legislative Delegation for fiscal year (FY) 2025.

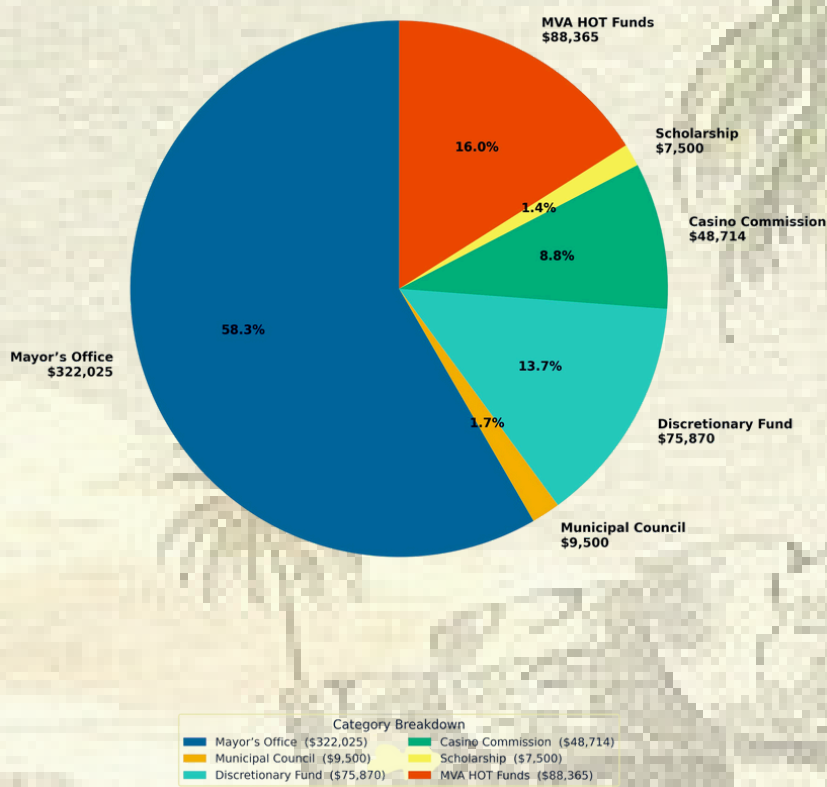
Appropriations under Tinian Local Laws (FY2025)

SUMMARY

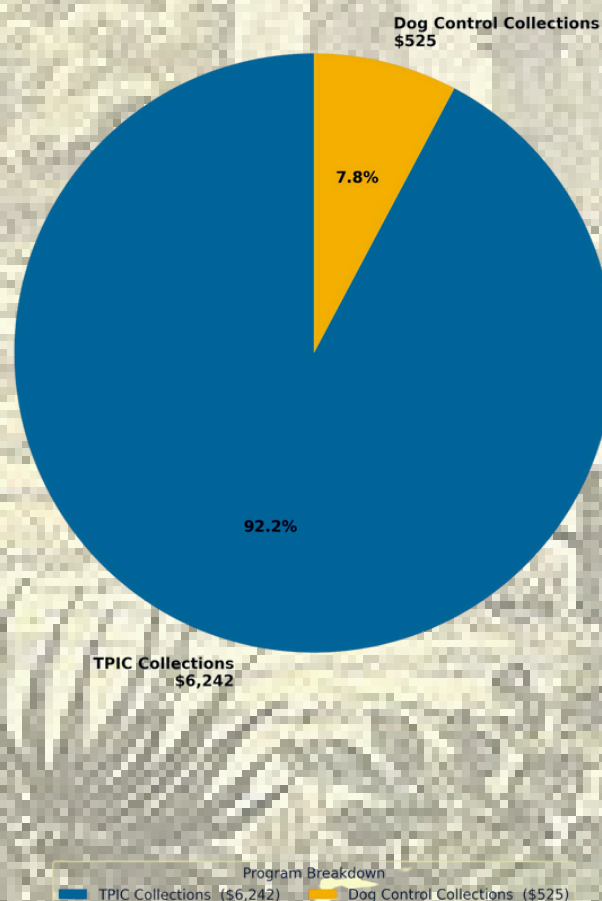
This report highlights how funds were appropriated and collected under Tinian Local Laws for Fiscal Year 2025.

Tinian Revenue Collections (FY2025)



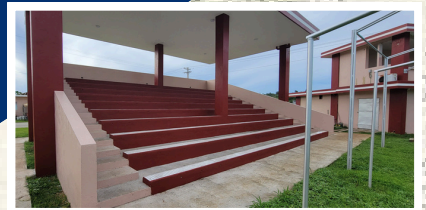
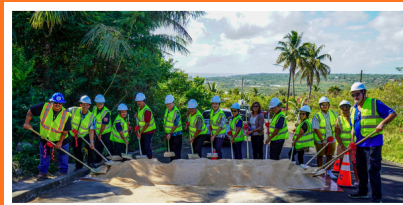
